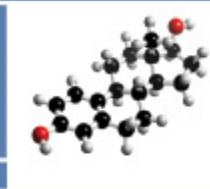
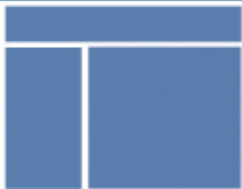


# Gradient Breakfast Seminar

## Endocrine Disruptor Screening Program

**REMINDER:** Gradient is hosting a free Endocrine Disruptor Screening Program (EDSP) breakfast seminar at the [Marriot at Metro Center](#) in Washington, DC on May 11, 2010.

Last year, the United States Environmental Protection Agency (US EPA) issued its first batch of Tier 1 test orders to pesticide manufacturers, registrants, and importers under its EDSP. These orders marked the beginning of a massive chemical screening program first envisioned in 1996. While pesticide screening under the EDSP has only just started, efforts are already underway to expand the program to include a wider range of drinking water contaminants (including pharmaceuticals and personal care products) and endocrine disruption may become a key issue under planned legislation to reform the Toxic Substances Control Act (TSCA). Meanwhile, many open issues remain regarding the interpretation and impact of the results of screening tests.

The objective of this breakfast seminar is to provide an open forum for discussion, and will be piloted by four experts who will present a concise overview of the key technical, business and regulatory issues associated with the EDSP and other planned/pending legislation.
